Benchmarker is included in the Club Data Online package so there is no fee for accessing this service. To access the Benchmarker service, simply complete this registration form and forward it to IDOL.

Subscription will commence once payment has been received and a password allowing access to the system has been issued. Special consideration will be given to clubs registering close to the data submission deadlines. One (1) invoice applies per subscribing club. Multi site clubs will be invoiced per site and are to register as participants.

If data is required to be delivered via facsimile, an administrative surcharge of \$11 (GST inclusive) per quarter applies. Terms and Conditions of Service

Invoicing

An upfront fee of \$550 (GST inclusive) will apply. This fee entitles participating clubs to four (4) Benchmarker quarterly releases over a 12-month period. An additional administrative fee of \$11 (GST inclusive) per quarter will apply to clubs that deliver their Benchmarker data via facsimile or indeed any other means other than online via the online self completion template on the Clubs Victoria website.

Cancellation and No-Refund Policy

If a club decides to cancel its subscription or chooses not to participate in all (four) 4 x Benchmarker quarterly releases they will not be refunded any portion of their subscription fees. If Clubs wish to cancel their subscription they must inform both Industry Data Online and Clubs Victoria either by telephone or email within seven (7) days of their decision.

Quarterly Releases

Benchmarker provides four (4) quarterly releases in each calendar year being for the March quarter (January, February, March), June quarter (April, May, June), September quarter (July, August, September) and December quarter (October, November, December). All participating clubs will be advised of a cut off date following each quarter by which data must be provided. Benchmarker results for each quarter will be posted online shortly after the cut off date. Data not received by the cut off date will not be included in the Benchmarker release for that quarter.

Industry Data Online Privacy Policy

Industry Data Online Pty Ltd and its related entities (IDOL) respect the privacy and confidentiality of your data. Raw data is only accessible by our staff for the purposes of analysis and dissemination on this site. Only consolidated data that does not reveal the details of any individual contributor is made available to contributors other than the contributor who provided the raw data.

1.1 Personal Information
